



PROPOSAL FORM FOR INSURANCE FOR COACHES/ UMPIRES

England Hockey is pleased to offer you the following Insurance Scheme for **qualified coaches and umpires** through **Perkins Slade Ltd** [CCPR recognised insurance brokers]. In addition to Liability insurance (through Royal & SunAlliance Plc), the package now also includes Legal Expenses insurance and advice (through DAS Insurance Group).

1. Liability Insurance

Cover: The Insurer will indemnify the Insured against all sums which the Insured shall become legally liable to pay as damages in respect of accidental bodily injury to any person or accidental loss of or damage to property including any error or omission arising out of activities as a qualified coach or umpire registered with England Hockey occurring within the Geographical Limits and happening during any Period of Insurance

In addition the Insurer will pay costs and expenses incurred by the Insured with the prior written consent of the Insurer in connection with any matter which may form the subject of a claim for indemnity under this insurance. It includes indemnity to the Insured for advice design or specification given for a fee.

The policy is written on a claims made wording.

Limit of

Indemnity: £5,000,000 any one occurrence (except for Products Liability which is in the aggregate)

2. Legal Expenses Insurance

Cover: Legal Defence

The Insurer will defend the insured person's legal rights prior to the issue of proceedings when dealing with the policy where it is alleged that the insured person has or may have committed a criminal offence in connection with the insured person's activities as a member of England Hockey Limited.

Bodily Injury The Insurer will negotiate for the insured person's legal rights after an event which causes the death of, or bodily injury to the insured person.

Limit: £25,000

Helplines: **Eurolaw Legal Advice Line**

A 24 hour advice helpline to provide legal advice on any personal problem under the laws of the member states of the EU, Isle of Man, Channel Islands, Switzerland and Norway.

Tax Advice Service

A 24 hour helpline to provide confidential advice on personal tax matters in the UK.

Health & Medical Information Service

Advice can be given on how to improve diet and fitness, travel health and sports injuries.

Counselling

24 hour counselling service is available to provide confidential counselling over the phone on such matters as relationship difficulties, debt counselling, bereavement, drug abuse etc.

COST: £40.00 [inclusive of 5% Insurance Premium Tax and administration fee]. Cheques should be made payable to England Hockey Ltd.

NOTE: Insurance will not commence until a correctly completed proposal form and payment is received by England Hockey.

A certificate of insurance will be issued to you.
